

**THE 5-hour ENERGY® FLAVOR VOTE SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. MESSAGE & DATA RATES MAY APPLY.**

**ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

1. **SWEEPSTAKES ENTRY PERIOD: The 5-hour ENERGY® Flavor Vote Sweepstakes** (the "Sweepstakes") begins at 12:00:01 AM Eastern Standard Time ("EST") on Tuesday, March 1, 2022 and ends at 11:59:59 PM Eastern Daylight Time ("EDT") on Thursday, June 30, 2022 (the "Sweepstakes Period"). EST and EDT are collectively referred to herein as "ET".
2. **ELIGIBILITY:** The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who are age 18 or older and the age of majority in their state of residence (19 or older in Alabama and Nebraska; 21 or older in Mississippi) at the time of entry. Void in Puerto Rico, Guam, the U.S. Virgin Islands, all other U.S. territories and possessions, outside the U.S., and wherever else prohibited by law. Employees of Living Essentials, LLC (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator) and their respective subsidiaries, affiliates, shareholders, directors, officers, members, successors, agents, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.
3. **HOW TO ENTER:**
  - During the Sweepstakes Period, eligible entrants must visit the Promotion Website by visiting **5HEVOTE.com** (the "Promotion Website") or texting the keyword "**5HEVOTE**" to shortcode **467467** to receive an automatic reply, via text message, with a link to the Promotion Website. **MESSAGE & DATA RATES MAY APPLY.** Reply STOP to 467467 to stop receiving text messages or reply HELP to 467467 for help.
  - Upon visiting the Promotion Website, eligible entrants must follow the instructions to register for the Sweepstakes by completing and submitting the registration form in its entirety and then following the instructions to submit their vote for the new 5-hour ENERGY® flavor (the "Vote"). By completing the registration form and submitting a Vote, eligible entrants will receive one (1) entry into the sweepstakes (the "Online Entry"). Each day thereafter, for the remainder of the Sweepstakes Period, eligible entrants may return to the Promotion

Website, provide their email address and submit a Vote to receive one (1) additional Online Entry into the Sweepstakes.

**There is a limit of one (1) Online Entry per person per day.** Any additional attempts to receive an Online Entry, excluding the Bonus Entries described below, will be void and ineligible. For the purposes of this Sweepstakes, a “day” is defined as the twenty-four (24) hour time period commencing at 12:01 AM ET, and ending at 11:59 PM ET. Although the Sponsor and/or Sweepstakes Administrator may receive a participant’s subsequent attempts to receive an Online Entry on a given day, only the first complete Online Entry received from a particular participant on that day will be eligible; subsequent attempts by the same person to enter during that same day (excluding Bonus Entries as described below), including entries submitted with an alternate email address, will be disqualified. ### **How to receive Bonus Entries:**

- A. **Bonus Entry Method #1: Twitter Share Bonus Entry.** Upon submitting an Online Entry, entrants will have the opportunity to refer the Sweepstakes to friends by publishing a tweet from his/her personal Twitter account (the “Twitter Share”). - B. **Bonus Entry Method #2: Purchase Bonus Entry:** Upon submitting an Online Entry, entrants will have the opportunity to earn bonus entries into the Sweepstakes by submitting a valid purchase receipt, as described below.

- Step One: During the Sweepstakes Period, purchase either one (1) single 5-hour ENERGY® product (bottle or can) or any multi-pack 5-hour ENERGY® product (bottle or can) (the “Qualifying Product”).
- Step Two: Collect your original, itemized, store-identified purchase receipt dated between 3/1/22 and 6/30/22 and underline, circle or otherwise highlight the Qualifying Product on the receipt (the “Receipt”). Keep your Receipt. Sponsor reserves the right to require a participant to provide original Receipt for verification purposes upon request. **Each Receipt submitted must be unique and there is a limit of ten (10) Purchase Bonus Entries per unique Receipt, regardless of the number of Qualifying Products indicated on the Receipt.**
- Step Three: Take a photo of the Receipt (the “Receipt Photo”). The Receipt Photo must clearly show store where purchased, purchase date and the Qualifying Product purchased. Receipt Photo must be in .jpg or .png format and should be no larger than 5 megabytes (5MB).
- Step Four: After submitting an Online Entry, follow the on-screen instructions to provide the name of the store where you purchased the Qualifying Product and upload the Receipt Photo to receive ten (10) bonus entries into the Sweepstakes (each, a “Purchase Bonus Entry”).
- After receiving a Purchase Bonus Entry, the Promotion Website will ask if you would like to submit an additional Receipt to receive ten (10) additional Purchase Bonus Entries. To submit an additional Receipt and receive an additional ten (10) Purchase Bonus Entries, follow the instructions to provide the name of the store where you purchased a separate Qualifying Product and upload that Qualifying Product’s Receipt Photo to receive ten (10) additional Purchase Bonus Entries. **You may repeat this process to receive up to fifty (50) Purchase Bonus Entries per day with a limit of up to five hundred (500) total Purchase Bonus Entries per person during the Sweepstakes Period. Each Receipt submitted must be unique and there is a limit of ten (10) Purchase Bonus Entries per unique Receipt, regardless of the number of Qualifying Products indicated on the Receipt.** Attempts to gain additional Purchase Bonus Entries by submitting a Receipt that has already been submitted to the Sweepstakes will be disqualified. Only valid Receipts and Receipt Photos will be accepted and are subject to verification and will not be returned. Any additional attempts to receive more than the allotted number of Purchase Bonus Entries will be void and ineligible. **Purchase Bonus Entries must be received between 12:00:01 AM ET on Tuesday, March 1, 2022 and 11:59:59 PM ET on Thursday, June 30, 2022.**

- C. **Bonus Entry Method #3: Free, Alternate Method of Entry (“Mail-In Bonus Entry”):** To receive ten (10) bonus entries without purchase, clearly hand-print your name, complete address, email address and phone number on a sheet of paper and mail that sheet of paper in an addressed envelope (the “Mailed Entry”) to: The 5-hour ENERGY® Flavor Vote Sweepstakes, PO Box 776, Social Circle, GA 30025-776. Each Mail-In Entry will earn ten (10) bonus entries into the Sweepstakes (each, a “Mail-In Bonus Entry”). **You may repeat this process to receive up to fifty (50) Mail-In Bonus Entries per day with a limit of up to five hundred (500) total Mail-In Bonus Entries per person during the Sweepstakes Period. - D. **Bonus Entry Method #4: Create Your Own 5-hour ENERGY® Flavor Bonus Entry:** Upon submitting an Online Entry, entrants will have the opportunity to receive one (1) bonus entry into the Sweepstakes by following the instructions to recommend a new 5-hour ENERGY® flavor for the Sponsor’s consideration (the “Create Your Own Flavor Bonus Entry”). **There is a limit of one (1) Create Your Own Flavor Bonus Entry per person per day.** Any additional attempts to receive more than the allotted number of Create Your Own Flavor Bonus Entries will be void and ineligible. **Create Your Own Flavor Bonus Entries must be received between 12:00:01 AM ET on Tuesday, March 1, 2022 and 11:59:59 PM ET on Thursday, June 30, 2022.** Entrants understand that by recommending a new 5-hour ENERGY flavor, Entrant grants the right to use the suggested flavor or flavor name without further approval. ENTRANT HEREBY GRANTS TO THE SPONSOR AND ITS LEGAL REPRESENTATIVES, SUCCESSORS AND ASSIGNS, ALL RIGHTS IN PERPETUITY THE SUBMISSIONS IN ANY FORM OR FORMAT AND TO

MODIFY THE SAME, AND ACKNOWLEDGES AND AGREES THAT IF SPONSOR DOES USE THE SUBMISSIONS ENTRANT SHALL NOT BE ENTITLED TO ANY CREDIT, CONSIDERATION, NOTICE OR PAYMENTS OF ANY KIND, EXCEPT AS EXPRESSLY PROVIDED HEREIN. ENTRANT WAIVES ANY MORAL RIGHTS HE OR SHE MAY HAVE TO THE SUBMISSIONS AND AGREES THAT IF SPONSOR ELECTS TO USE SUBMISSIONS FOR ANY PURPOSE, ALL RIGHTS UNDER COPYRIGHT OR OTHER INTELLECTUAL PROPERTY RIGHTS THAT MAY RESULT FROM THAT RELATING TO ENTRANT'S SUBMISSIONS OR FROM USE OF THE SAME BY SPONSOR SHALL BE THE SOLE PROPERTY OF SPONSOR. Entrants understand that any recommended 5-hour ENERGY® flavor submitted to Sponsor may or may not be used by Sponsor and that the Sponsor reserves the right to change any submission. Your submission shall not be subject to any obligation of confidence on the part of the Sponsor, and its respective agents, subsidiaries, affiliates, partners or third-party service providers and their respective directors, officers and employees. Under no circumstances shall the Sponsor and/or its affiliates be liable for any damages or injury, including any direct, special, incidental, consequential, punitive or other damages, that may result from the use of, or inability to use, the submission.

- E. **Bonus Entry Method #5: Facebook Comment Bonus Entry:** During the Sweepstakes Period, @5hourEnergyShot will periodically post on Facebook inviting participants to comment on the post to receive a bonus entry (each, a “@5hourEnergyShot Post”). To receive one (1) bonus entry, look for a qualifying @5hourEnergyShot Post on Facebook and follow the instructions to comment on the post to receive one (1) bonus entry into the sweepstakes (the “Facebook Comment Bonus Entry”). **There is a limit of one (1) Facebook Comment Bonus Entry per person per @5hourEnergyShot Post with a maximum of eight (8) total Facebook Comment Bonus Entries per person.** Any additional attempts to receive more than the allotted number of Facebook Comment Bonus Entries will be void and ineligible. **Facebook Comment Bonus Entries must be received between the posting of the @5hourEnergyShot Post and 11:59:59 PM ET on Thursday, June 30, 2022.**
- F. **Bonus Entry Method #6: Instagram Comment Bonus Entry:** During the Sweepstakes Period, @5hourEnergy will periodically post on Instagram inviting participants to comment on the post to receive a bonus entry (each, a “@5hourEnergy Post”). To receive one (1) bonus entry, follow @5hourEnergy on Instagram, look for a qualifying @5hourEnergy Post and follow the instructions to comment on the post to receive one (1) bonus entry into the sweepstakes (the “Instagram Comment Bonus Entry”). **There is a limit of one (1) Instagram Comment Bonus Entry per person per @5hourEnergy Post with a maximum of eight (8) total Instagram Comment Bonus Entries per person.** Any additional attempts to receive more than the allotted

number of Instagram Comment Bonus Entries will be void and ineligible. **Instagram Comment Bonus Entries must be received between the posting of the @5hourEnergy Post and 11:59:59 PM ET on Thursday, June 30, 2022.**

**This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Twitter, Facebook or Instagram.** Multiple participants are not permitted to share the same Twitter account, Facebook account or Instagram account. - 4. PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:** There are five (5) Grand Prizes available to be won. Each Grand Prize winner will receive a trip package to winner's choice of location up to \$10,000 in value. Trip package may include flights, car rental, ground transportation, hotel, cruise, tickets for activities and events (if available) and cash allowance of up to \$1,000. The total maximum ARV of each Grand Prize is: \$10,000. The difference in value of the actual trip package and the ARV will not be awarded.

Odds of winning will depend upon the total number of eligible Entries received.

- 5. RANDOM DRAWING:** The winners will be selected in a random drawing on or about Monday, July 11, 2022 from among all eligible Entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION:** The potential Grand Prize winners will be notified via email and/or phone, and will be required to sign and return, within five (5) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Grand Prize winner to furnish his/her Social Security Number for the purpose of tax reporting, as required by law. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any other incidental expenses on prize not specified herein are the winner's sole responsibility.

**All travel related expenses, including but not limited to, taxes, gratuities, incidentals, upgrades, insurance, service charges,**

**airport surcharges, departure taxes, hotel, resort or property fees, luggage fees, food & beverage and personal expenses are the sole responsibility of prize winner and/or his/her travel companion(s). Winner and travel companion(s) must travel on same itinerary.**

Winner and travel companion(s) must have valid photo ID and any other required documentation prior to departure. Travel is subject to availability.
