The Entry that receives the highest judging score will be determined the potential Grand Prize winner. The Entry that receives the third highest judging score will be determined the potential Second Prize winner. In the unlikely event of a tie, the tied Entry with the highest score in Criterion A, will be determed the potential winner. If additional tie breakers are needed, the tie-breaking mechanism above will be used; however, instead of the highest score in Criterion A determining the potential winner. In the event additional tiebreakers are needed, all tied Entries will be judged by a separate panel of judges using the judging criteria above.
