#### **HOW TO ENTER:**

### There are two (2) ways to enter the Sweepstakes:

  - <u>Step Three</u>: Take a photo of the Receipt (the "Receipt Photo"). The Receipt Photo must clearly show store where purchased, purchase date and the Qualifying Purchase purchased. Receipt Photo must be in .jpg or .png format and should be no larger than 5 megabytes (5MB).
  - Step Four: Visit 19crimes.com/sipgrillchill (the "Sweepstakes Website"), follow all entry instructions to complete the required fields within the entry form, upload the Receipt Photo and submit to receive one (1) entry into the Sweepstakes (the "Purchase Entry"). After submitting a Purchase Entry, the Sweepstakes Website will ask if you would like to submit an additional Receipt to receive an additional Purchase Entry. To submit an additional Receipt and receive an additional Purchase Entry, follow the instructions to upload a Receipt Photo of a Receipt from the purchase of a separate Qualifying Purchase.
