

## THE #BESTIEBOWLS GIVEAWAY OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

By participating in the **#BestieBowls Giveaway** (the “Sweepstakes”), you unconditionally accept and agree to comply with and abide by these Official Rules (“Official Rules”) and the decisions of Mars Petcare US, Inc. (the “Sponsor”) and US Sweepstakes & Fulfillment Co. (the “Sweepstakes Administrator”), which shall be final and binding in all respects. All applicable federal, state, and local laws and regulations apply.

**HOW TO ENTER:** Take a photo of yourself and your dog or dogs (each, a “Dog”) sharing a moment of joy (the “Photo”) and submit it through one (1) of the two (2) methods below:

**Method #1: Online Entry. **RANDOM DRAWINGS & WINNER NOTIFICATION/VERIFICATION:** Entries and Bonus Entries are collectively referred to herein as “Entry” or “Entries”. If a potential Daily Prize winner entered via Instagram Entry, he/she/they will be notified via direct message and/or Photo comment to his/her/their public Instagram account and will be required to respond to the notification with his/her/their full name, email address, shipping address and phone number within two (2) days via return direct message.
