

**THE MATUA ROCK & REFRESH SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. NO ALCOHOLIC BEVERAGES ARE INCLUDED IN ANY PRIZE.

By participating in **The Matua Rock & Refresh Sweepstakes** (the "Sweepstakes"), each entrant ("Entrant") unconditionally accepts and agrees to comply with, and abide by, these Official Rules (the "Official Rules") and the decisions of Treasury Wine Estates Americas Company (the "Sponsor"), which shall be final and binding in all respects.

SWEEPSTAKES ENTRY PERIOD: The Sweepstakes begins at 12:00:01 AM Pacific Time ("PT") on Friday, July 1, 2022 and ends at 11:59:59 PM PT on Sunday, August 28, 2022 (the "Sweepstakes Period").

completed and successfully submitted. **There is a limit of one (1) Bonus Entry per Bonus Entry Action per person. Maximum of three (3) Bonus Entries per person.**

- Click on the link to visit @matuawine on Instagram and then click the “Follow” button to follow @matuawine.
- Click on the link to follow Matua Wines on YouTube and then click the “Subscribe” button to subscribe to Matua Wines’ channel.
- Follow the instructions to vote for the photo that represents the best way to stay cool and refreshed during the summer.

Facebook Ad Entry, Online Entry, and Bonus Entry are collectively referred to herein as “Entry” or “Entries”. Any attempt by an Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins, and/or any other methods, including, but not limited to, Entries generated by script, macro or other automated devices will void that Entrant’s Entries and that Entrant may be disqualified from the Sweepstakes. Multiple participants are not permitted to share the same email address. Incomplete entries will not be accepted and are void. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the “Authorized Account Holder” of the e-mail address submitted at time of entry. Authorized Account Holder means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Sponsor may ask any entrant or potential winner to provide Sponsor with proof, to Sponsor’s satisfaction, that such party is the authorized account holder of the email address associated with the entry. All entries become the property of the Sponsor and will not be acknowledged or returned. All methods of entry have an equal chance of winning.**

PRIZES/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS: There is one (1) Grand Prize available to be won. One (1) Grand Prize winner will receive a trip package for two (2) people, Grand Prize winner and one (1) guest (the “Guest”), to attend the 2022 Life is Beautiful Festival in Las Vegas, Nevada. Grand Prize trip package includes:

- Two (2) 3-day VIP Passes to the 2022 Life is Beautiful Festival scheduled to take place September 16 – September 18, 2022;
- Round-trip, coach-class air-transportation for Grand Prize winner and Guest to Las Vegas, Nevada from a major airport nearest the winner’s residence as determined by Sponsor;

RANDOM DRAWING: The Grand Prize winner will be selected in a random drawing on or about **Monday, August 29, 2022** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: The potential Grand Prize winner will be notified by the Sweepstakes Administrator via email and/or phone, and will be required to sign and return, within 48 hours of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). Event passes and Uber vouchers will not be replaced if lost or stolen and are subject to terms and conditions of the issuing company. In the event the Event does not take place as scheduled, for reasons such as cancellation, preemption or postponement, or for any reason beyond the control

of the Sponsor, Sponsor's sole responsibility will be to award the remaining portion of the Grand Prize and no additional substitution or compensation will be provided.

THE ARBITRATION SHALL BE ADMINISTERED BY JAMS PURSUANT TO ITS COMPREHENSIVE ARBITRATION RULES ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE
