The Nominator associated with the winning nomination of a Teacher Nominee Daily Prize winner will be determined as a potential Nominator Daily Prize winner, subject to verification of their Teacher Nominee and compliance with these Official Rules. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction.
