## THE 19 CRIMES INFAMOUS OR ICONIC SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. NO ALCOHOLIC BEVERAGES ARE INCLUDED IN ANY PRIZE.

By participating in **The 19 Crimes Infamous or Iconic Sweepstakes** (the "Sweepstakes"), each entrant ("Entrant") unconditionally accepts and agrees to comply with, and abide by, these Official Rules and the decisions of Treasury Wine Estates Americas Company (the "Sponsor"), which shall be final and binding in all respects.

**SWEEPSTAKES ENTRY PERIOD:** The Sweepstakes begins at 12:00:01 AM Pacific Time ("PT") on Wednesday, September 15, 2021 and ends at 11:59:59 PM PT on Monday, November 15, 2021 (the "Sweepstakes Period"). Sponsor's computer is the official timekeeping device for this Sweepstakes.

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the 50 United States (excluding Utah) and the District of Columbia, who are age 21 or older at the time of entry. Void in Utah, Puerto Rico, Guam, the U.S. Virgin Islands, all other US Territories and Possessions, outside of the U.S., and wherever else prohibited by law. - <u>Step Three</u>: Take a photo of the Receipt (the "Receipt Photo"). The Receipt Photo must clearly show store where purchased, purchase date and the Qualifying Purchase purchased. Receipt Photo must be in .jpg or .png format and should be no larger than 5 megabytes (5MB).
- Step Four: Visit 19CrimesInfamousorIconic.com (the "Sweepstakes Website"), follow all entry instructions to complete the required fields within the entry form, upload the Receipt Photo and submit to receive one (1) entry into the Sweepstakes (the "Purchase Entry"). Each Receipt submitted must be unique and there is a limit of one (1) Purchase Entry per unique Receipt, regardless of the number of Qualifying Purchases indicated on the Receipt. Attempts to gain a Purchase Entry by submitting a Receipt that has already been submitted to the Sweepstakes will be disqualified. Only valid Receipts and Receipt Photos will be accepted and are subject to verification and will not be returned. Mechanical reproductions, altered receipts or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted.

Attention California Residents: An Entrant who is a resident of California may not enter the Sweepstakes by making a Qualifying Purchase and uploading a receipt at the Sweepstakes Website. Method #2: Free, Alternate Method of Entry ("AMOE") / Mail-in Entry. To enter without purchase, mail a postcard (the "Mail-In Entry"), including your name, complete address, email address and phone number to the following

address to receive one (1) entry into the Sweepstakes: The 19 Crimes Infamous or Iconic Sweepstakes, PO Box 776, Social Circle, GA 30025-776. Each Mail-In Entry must be mailed separately and must be postmarked between Wednesday, September 15, 2021 and Monday, November 15, 2021 and received by Monday, November 22, 2021.   - Round-trip, coach-class air transportation for winner and one (1) guest to San Francisco, California from a major airport within the 50 United States nearest the winner's residence as determined by Sponsor;
  - Three (3) nights first-class hotel accommodations at a hotel of Sweepstakes Administrator's choice based on single room/double occupancy;
  - Two (2) Alcatraz Behind the Scenes Tour tickets; and

- o One (1) \$500 pre-paid gift card. The ARV of Grand Prize Option #1 is: \$3,900. The ARV may vary based upon dates of travel and point of departure. The difference between the ARV and actual value of the Grand Prize will not be awarded. Travel must take place prior to December 31, 2022. Travel arrangements must be booked at least 60 days in advance.

  - Two (2) tickets to a Snoop Dogg concert of Sponsor's choice; and
  - o One (1) \$500 pre-paid gift card.

The ARV of Grand Prize Option #2 is: \$4,700. The ARV may vary based upon dates of travel and point of departure. The difference between the ARV and actual value of the Grand Prize will not be awarded. Trip dates and location to be determined by Sponsor, based on 2022 concert tour dates and availability.

The total maximum ARV of all prizes available to be won: \$9,400. No Alcohol Beverages are included in any prize.

Odds of winning will depend upon the total number of eligible entries received.

**RANDOM DRAWING:** The potential winners will be selected in a random drawing on or about **Tuesday, November 23, 2021**, from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: The potential Grand Prize winners will be notified via email and/or phone and will be required to sign and return, within five (5) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases").
